<p><b>Lithotripsy Technologist:</b> The Lithotripsy Technologist must have equivalent qualifications, competence and function in the same role as employed individuals performing the same or similar services at the facility, as defined by facility job description.</p> <p><b>Definition of Care or Service:</b> The Lithotripsy Technologist assists urologist during a lithotripsy procedure. Scope of Service may include:</p> <ul style="list-style-type: none"> <li>• Assists the urologist by operating the ESWL equipment</li> <li>• Anticipates the moves of the urologists and assists in the safe and efficient completion of the lithotripsy procedure</li> <li>• Responsible for patient care procedures that relate directly to the lithotripsy procedure</li> <li>• Demonstrates strict compliance with all protocols as stated in ESWL equipment Policy and Procedure Manual</li> <li>• Responsible for the upkeep of the equipment and supplies in order to perform procedures in an efficient and aesthetic manner.</li> <li>• Demonstrates Clinical and Service excellence behaviors to include code of HCA Healthcare conduct core fundamentals in daily interactions with patients, families, co-workers and physicians.</li> </ul>

### Competencies:

The Lithotripsy Technician will demonstrate:

- Safe environment for patients
  - Uses at least two ways to identify patients before treating or performing a procedure
  - If the patient is not mobile enough to move onto the lithotripsy table themselves, the facility will provide appropriate assistance
  - Lithotripsy Technician will remain with the patient at all times while the patient is on the lithotripsy table or undergoing the procedure
  - The patient will have a loose safety strap around them at all times while on the lithotripsy table.
- Participates in a time-out immediately before the start of the procedure
- Lithotripsy Technician Skills
  - Standard patient positioning
  - Operation of the Lithotripter
  - Quality control checks of Lithotripter
  - Installation and dismantling of the equipment
  - Equipment troubleshooting
  - Aesthetic protocols
  - System components, including:
    - Therapy head movement, locks and switches, hand-control unit and bellow inspection
    - Calibration – targeting, warm-up and error messages
    - Ultrasound System – Major features and switches
    - Therapy Table – Features, handling and set-up
- Accurate patient information review and evaluation
  - Uses at least two ways to identify patients before providing care or treatment
  - Participates in a time-out immediately before the start of the procedure
  - Accesses the patient medical record appropriately and maintains confidentiality and privacy in accordance with HIPAA regulations.
  - Documents in the medical record according to the facility standard / policy when appropriate
  - If the patient is not mobile enough to move onto the lithotripsy table themselves, the facility will provide appropriate assistance
  - Lithotripsy Technician will remain with the patient at all times while the patient is on the lithotripsy table or undergoing the procedure
- Infection prevention
  - Practices consistent hand hygiene
  - Uses personal protective equipment (PPE) when required
  - Required immunizations per Division requirements
  - Complies with Isolation precautions
  - Complies with required surgical attire
  - Maintains sterile field
